## Bibliography: History of Education in Canada 1980–1999

Long-time subscribers to Historical Studies in Education/Revne d'histoire de l'éducation will recall it was preceded in the early 1980s by a newsletter. Newsletter and journal provided a cumulative bibliography of work in the field of Canadian history of education, prepared by Wyn Millar. We here continue that practice, offering a compilation of bibliographies published over the past fifteen years or so in this journal—with an extension to include work that has appeared in the past five years, and items discovered by our team of bibliographical hunter-gatherers: Martin Bailey, Russell Wodell, and William Bruneau. We have built this listing on the foundation provided by Wyn Millar, but any omissions and errors are in no way due to her work.

As did Wyn, we rely on standard bibliographical sources and search devices. As Wyn wrote in introductions to earlier versions of the bibliography, the listing could never be "complete." After all, study and research on the history of education are changing quickly, even as allied fields and disciplines move in new directions. There is no straightforward way to define the field so as to catch all publications "related to" the history of education in Canada. Readers may, in consequence, wish to consult university library catalogues, standard bibliographical services, and bibliographies to well-known works in the field of Canadian educational history. Our listing, constrained by circumstance and sources to include only a representative body of work, should suggest lines of further bibliographical inquiry. We hope our coverage is broad and deep enough to include most research in the history of education in Canada published in the 1980s and 1990s.

We have decided to "publish" the entire list on the Web site of Historical Studies in Education/Revue d'histoire de l'éducation, in tandem with its appearance in these physical pages. Our listing appears in two parts, the first for work published in the 1980s, and the second for work from the 1990s. We found no readily adaptable system of detailed categories for presentation of the bibliography. There is such a system, of course, in use in the annual bibliographical numbers of Histoire de Véducation [Paris.] The bibliography in Histoire offers a remarkable and attractive arrangement of publications mainly on the history of education in France and in French-speaking parts of the world. Adoption of our French colleagues' system would have required an investment of computing and human time beyond the means of HSE/RHE. We hope that at some future time, it may be possible to adopt an analogous system in the version of the bibliography placed on the journal's web site.

For the time being, we therefore present the list alphabetically, and in two chronologically distinct parts.
